** In no case shall a Medicolegal Investigator receive more than the annual maximum amount in a year. Employees shall be eligible to receive the shift amount for each full eight (8) hour tour during which the Medicolegal Investigator drives him/herself to and between assignments. The differential shall not be paid while the employee is on sick, annual or any other leave, including use of compensatory time. Any Medicolegal Investigator who is assigned to a tour which does not require the Medicolegal Investigator to travel between locations shall not be eligible for the differential during that tour.

*** Medicolegal Investigator transportation differential increase includes the adjustment for their new 13:20 shift length effective January 29, 2017.
